This Certificate is issued subject to the following conditions:-

- **Screening & Hygiene** Provision for Thermal scanning, hand wash or sanitizer will be made at all entry points and of hand wash or sanitizer at all exit points and common areas.
 - **Frequent Sanitization** of entire place, common facilities and all points which come into human contact e.g.door handles etc., will be ensured, including between shifts.
 - **Social Distancing** All persons in charge of work places will ensure adequate distance between students, staffs, workers, adequate gaps between staggering the intervals, the lunch breaks etc.,
- 1) The Garbage generated within the trust premises should be collected and disposed off Properly by appointing required Sanitary Staff.
 - 2) On any Account, the Garbage should not be burnt.
 - 3) The children should be educated to prevent the usage of plastics in the School/ Institution premises and no one should bring plastic carry bags, use and throw Tumblers to the School/Institution.
 - 4) N.O.C.Should be obtained from the Deputy Director of Health Services, to run a food establishment within in premises.
 - 5) Fire precaution measures, and First Aid Box, should be provided.
 - 6) Child labour should not be engaged in any account.
 - 7) Every person in charge of place of public work should use small display and exhibit a board at a conspicuous place in or outside the place prominently stating that the place is a "No Smoking area. Smoking is an offence" and "Tobacco-Free institution, Sale or offer of cigarettes or other tobacco products is strictly prohibited in the area within a radius of 100 yards" which shall be both in Tamil and English and the version in the second place below the Tamil version.
 - 8) This Certificate issued is liable to be cancelled at any time on infringement if any of the above said conditions and for improper maintenance of sanitation, improper maintenance of the building as well as toilets in the institute.
 - 9) This Sanitary Certificate valid one year only from the date issue.

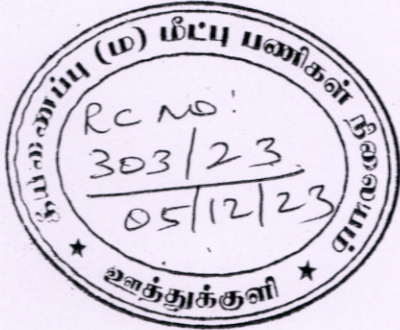
