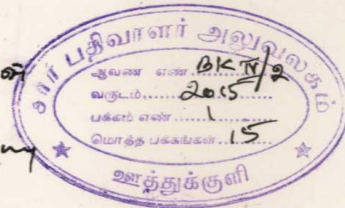

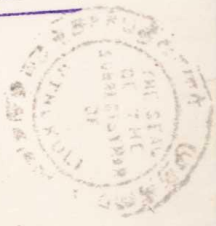

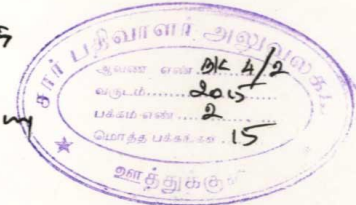

7. NUMBER OF THE TRUSTEES:

The number of trustees shall not be less than three and not more than eleven.

8. CESSATION OF TRUSTEESHIP:

A Trustee mentioned below shall cease to be the trustee of the Trust if:-

- (a) he resigns;
- (b) he becomes insolvent or insane or death;
- (c) he is removed by the 2/3 (two/three) majority of the members of the trustees, if it is found that the trustee(s) activities are detrimental to the activities or administration of funds of the Trust.

9. DURATION AND APPOINTMENT OF TRUSTEES:

The Trustees shall hold the office for their respective life's or till cessation. Any vacancy of Trustees shall be filled up by the remaining members of the Trust selecting a suitable person. The trustees may also Co-opt new trustees for the benefit of the trust at the decision of the trustees. The new trustee(s) selected of Co-opt shall have the same powers as the existing trustees after such selection or co-option.

10. ADMINISTRATION OF THE TRUST;

The day-to-day conduct, Management and administration of the affairs of the Trust shall be carried on by Mr. S. Chandrakumar who shall be known as the "Managing Trustee" of the Trust.

11. The POWERS OF TRUSTEES:

1. To receive all trust funds and money by way of gifts, donations, contributions and grants to the Trust.
2. The trustees shall participate in the board of trustees meeting and act for the benefit and to achieve the object of the Trust.
3. The trustees do all the acts as delegated by the Managing Trustees.

12. THE MANAGING TRUSTEE SHALL HAVE POWERS:

- a. To have control over the assets of the Trust and to execute, sign, acknowledge, and register all deeds, agreements and writing and to give effectual discharge on behalf of and against the Trust;
- b. To draw, make, accept, endorse, discount, negotiate, execute, cheques, bill of exchange and other negotiable instruments.
- c. To borrow moneys such as loan from any financial institution, persons, Banks etc and execute documents in relating to the loan .

- d. To institute, conduct, defend, compound, withdraw or compromise, adjust, refer to arbitration or abandon any legal or other proceedings, claims or disputes by or against the Trust or Trustees or against its officers or employees concerning the affairs of the Trust and to Sign and verify vakalaths , Plaint, written statements, affidavits and other proceedings before all courts and other Government authorities;
- e. To appoint from time to time and at any time to suspend dismiss, remove or discharge any person under their control including clerks, accountants and other employees and fix their power and duties and upon such terms, duration of office, remuneration or otherwise as the ' board of Trustees ' shall think proper.
- f. To do such other acts or deeds consistent with powers conferred herein and such other acts authorized by the Board of Trustees by a resolution.
- g. Subject to the approval by the Board of Trustees in writing the Managing Trustee shall nominate a trustee who will be Secretary of the Trust to perform all or any of the functions mentioned in Classes above.
- h. The Managing trustee shall delegate his powers to any trustee or authorized person to do the all or any of the functions mentioned in classes above.

13. MEETINGS AND RESOLUTIONS:

- a. The board of trustees shall meet at least once in every three months, and often if necessary on a written requisition maid by any trustee to all board of trustees through registered post. the quorm for the meeting shall be three.
- b. The chairman of the meeting shall be the Managing Trustee or in his absence the oldest person present at the meeting.
- aThe vote of majority present at the meeting shall prevail and in the event of equality of votes, the person presiding such meeting shall exercise casting vote (additional vote).
- c . No act or resolutions of the board shall be invalid merely by reason of there being one or more vacancies in the board of trustees.
- d. The board of trustees will also be competent to make and prescribe for time to time rules and bye-laws, rules and regulations for the carrying out of the objects of Trust and all other matters incidental to carrying out of the Trust and also modify or amend such bye-laws rules and regulations within the frame work of the Trust .

14. SUITS:

The Managing Trustee of the Trust is authorized to sue or to be sued on behalf of the Trust.

15. Execution of Documents:

All Deeds, Documents etc, shall be executed by the Managing Trustee who represent the Trust.

16. ACCOUNTS AND AUDIT:

- a. The Trustees shall maintain true and correct accounts of all Trust monies and of all the income and investments and all the outgoing expenses.
- b. The year of account shall be the financial year commencing from 1st APRIL and ending 31st March of every year.
- c. The Trustees shall each year issue a report setting out the accounts showing the income and expenditure of the Trust for the preceding year not later than six months from the end of the preceding year of accounts.
- d. The accounts of the Trust shall be audited every year by a Chartered Accountant who may be appointed for the purpose by the board of Trustees and the audited statement of accounts together with Auditor's report shall be laid before the Trustees for approval.

17. BANK ACCOUNT:


The Managing Trustee along shall operate bank account(s) jointly with any one of the trustee.
